### **Presidential report: Terry**

- Review Weight limit and age bracket changes
  - **Motion was made by Tonie Ann that once your weight has determined your squad level, you will stay with that squad for the entire season. The only thing that can change is ball carrier status if they are over 155. We will keep in place the original play up rules to field a team. Seconded by Ryan Koleber. Voted passed w 5 votes.**
  - Weigh-ins – **Who? Motion by Tonie Ann - All players that weigh 150 or above at registration will be flagged to weigh in for each game and determined ball carriers or not. Seconded by Corey Overholt. Vote passed w 6 votes.**
  - Weigh-ins – **When? Motion by Tonie Ann – 150 lb and above players will weigh in every game before being allowed to play. Weigh in will be with a Non-head coach Executive board member only in the equipment room. Seconded by Terry Kirkpatrick. Voted passed w 6**
  - Consequences – If a coach has a designated player over 155 touch the ball –
    - **Motion by Jason Weichman – If a squad coach violates – the Head Squad coach will be suspended for a calendar year from all games and practices. Example: If it happens during game 3, you will be suspended till game 3 of the next season. And the organization will forfeit all 1<sup>st</sup> round draft picks. If this organization violates this rule again - The Head coach will also be suspended for 2 games and practices. Seconded by Robert Borisch. Voted passed by 6 coaches**
    - **Motion by Jason Weichman to adopt a 3 year band where the weight limits are averaged to even the squads out just like previous years. Seconded by Nicole Clayton. Vote passed w 5 votes.**

**A – 11, 12, 13**

**B – 10, 11, 12**

**C – 9, 10, 11**

**D – 8, 9, 10**

**E – 6, 7, 8**
